一、 舉辦背景:

本系列課程邀聘具有豐富國際金融實務及教學經驗之專家擔任講座,依據銀行業核心人才職能發展需要,設計法令遵循、貿易融資、企業金融、風險管理、財務金融等五大領域課程,透過觀念講授、個案研討及模擬演練等多元化教學方式,強化銀行業人士專業能力,建立新觀念與新技巧。

二、 舉辦方式:
